

NOTICE TO THE BAR

Changes in Assignment and Programs in the Criminal Trial Division

The following changes in assignment and programs are effective January 7, 2002 with the exception of the Honorable Joan A. Brown whose assignment is effective January 15, 2002.

The Honorable Lisa A. Richette is reassigned from the List Program to Section B in the Section Calendar Program and will preside in Courtroom 807. Judge Richette will assume the Honorable Richard B. Klein's major felony inventory presently listed in Courtroom 807.

The Honorable Joan A. Brown is reassigned from the List Program to Section E in the Section Calendar Program and will preside in Courtroom 801. Judge Brown will be assigned Judge Lineberger's major felony inventory previously listed in Courtroom 701. Her assignment commences on January 15, 2002.
