

**NOTICE - COURT SCHEDULE FOR WEEK OF 7/31/2000  
(REPUBLICAN NATIONAL CONVENTION)**

During the Republican National Convention, except as noted below, the First Judicial District will be open for business as usual.

**COURT OF COMMON PLEAS. TRIAL DIVISION:** All trials of jury and non-jury cases in both the Civil and Criminal Divisions will be suspended except for those trials in progress, whether jury or non-jury, as of July 31, and it should be noted that jury trials commenced prior to July 31 will proceed to completion irrespective of the RNC week convention activities. In addition, Hearings or trials will be held *as scheduled* for the following: **Civil:** Arbitration hearings; routine and emergency Discovery hearings; Motion and Commerce Programs; **Criminal:** motions; track room listings; arraignment court; bench warrant hearings; and prison hearings. **JURY SELECTION WILL PROCEED AS USUAL ON FRIDAY, AUGUST 4, 2000.**

**FAMILY COURT DIVISION: 34 S. 11th Street (Domestic Relations Section):** Except for Civil Abuse hearings which will be held as usual, all judicial hearings or trials are suspended. All conferences (custody, enforcement, interstate and pre-trial) and Master's hearings (custody, divorce and support) will be held as usual. **1801 Vine Street:** All Adult criminal cases scheduled for Courtroom "B", Delinquent, and Adoptions cases will be suspended.
