1. The Domestic Relations Section of the Family Division handles all child support matters for Philadelphia cases.
2. All documents are filed at Domestic Relations, 34 South 11<sup>th</sup> Street, Philadelphia, PA 19107. The hours of operation are Monday to Friday, 8:00am to 5:00pm.
3. After a complaint is filed, a pretrial conference is scheduled. At the conference, a hearing officer will review the support guidelines with the parties and see if an agreement can be reached. If an agreement cannot be reached, the case is listed for a hearing before a support master.
4. Requests for continuances must be made in writing no later than ten calendar days before the date of the conference or hearing. For conferences, the request must be submitted to the hearing officer. For hearings, the request must be submitted to the judge or master. When a final support order is entered through either a decision by the presiding official or agreement, the payer is required to make timely payments to the court pursuant to the support order. Failure to make timely payments may result in a bench warrant issued for your arrest.
5. If a bench warrant is issued for your arrest for failure to comply with a court order, you may surrender voluntarily to the Bench Warrant Unit of Domestic Relations which is located at 34 South 11<sup>th</sup> Street, Room B-15, Philadelphia, PA 19107. The phone number for the Bench Warrant Unit is 215-686-2926. You must be prepared to bring your arrearages up to date when surrendering.
6. Modifications to a support order may be filed at any time after the final order as circumstances change. As with any other filing, a petition to modify a support order is filed at Domestic Relations, 34 South 11<sup>th</sup> Street, Philadelphia, PA 19107.

7. A parent locator service is provided by the court. This unit is located at 46 South 11<sup>th</sup> Street, Room 407, Philadelphia, PA 19107, phone number, 215-686-7763. This unit will attempt to help you locate a parent if you are unable to do so yourself.
8. Certified or exemplified (officially authenticated) copies of documents are obtained from the Clerk of the Family Court, 1133 Chestnut Street, 1<sup>st</sup> Floor, Philadelphia, PA 19107.
