### **Changes In Judicial Assignments In The Criminal Trial Division Effective Monday, September 8, 2003**

The Honorable Gary S. Glazer is reassigned from the Civil Trial Division to Section Calendar Program in the Criminal Trial Division. Judge Glazer is assigned to Section C and assumes the homicide only inventory previously assigned to the Honorable Steven R. Geroff. Judge Glazer will preside in Courtroom 1102.

The Honorable Steven R. Geroff will remain assigned to Section C in the Section Calendar Program and will continue to preside in Courtroom 802. Judge Geroff's inventory will consist of cases administratively transferred from other major felony inventories and those assigned from the Major Felony Pretrial Calendar Room.

The Honorable Harold M. Kane is reassigned from the List Program to the Section Calendar Program as Section B Leader. Judge Kane will preside in Courtroom 1105 and assume the mixed calendar inventory previously assigned to the Honorable Gregory E. Smith.

The Honorable Gregory E. Smith is reassigned from the Section Calendar Program in the Criminal Trial Division to the Civil Trial Division.

The Honorable Thomas Dempsey is reassigned from the Track Program to Section E in the Section Calendar Program. Judge Dempsey will preside in Courtroom 901 and will assume the major felony inventory previously assigned to the Honorable Annette M. Rizzo.

The Honorable Annette M. Rizzo is reassigned from the Section Calendar Program in the Criminal Trial Division to the Civil Trial Division.

Judge Hughes will remain in Section A and will continue to preside in Courtroom 902.

The Honorable Joseph A. Dych is reassigned from the List Program to the Track Program. Judge Dych will preside in Courtroom 503.

The Honorable Glynnis Hill is reassigned from the Family Court Division to the List Program in the Criminal Trial Division. Judge Hill assumes the felony waiver inventory previously assigned to the Honorable Harold M. Kane in Courtroom 704.
